Compliance Corner

Required Documents for Graduating Students (or age 21)

- ♦ Summary of Performance (SOP)
 - Presented no more than 60 days prior to graduation
- ♦ NOA
- Notice of Action-Exiting/Graduation, Change in Services, Change in Placement
- Include statement about required graduation credits under Other Relevant Factors, i.e.-"Graduation, and change in services and placement are contingent upon Student meeting the graduation requirements of the State of Missouri and the X School District. Should Student fail to meet the requirements, no change in services or placement will occur."

♦ Destruction of Records

Records must be maintained for at least 3 years following graduation or last day of service.

Mental Health Tidbit

With the recent events regarding flooding and road closures in northwest Missouri, this month I wanted to pass along two resources from the National Association of School Psychologists (NASP) about school safety and responding to crisis during natural disasters. Some take away points:

- Natural disasters can be especially traumatic for children and youth. The event itself can
 be frightening, the devastation of a familiar environment (e.g. school, home, community),
 and the loss of the sense of security and normalcy can be long-lasting for children.
- Although natural disaster events may only last a short period, survivors can be involved
 with the aftermath and recovery for months or even years. Collaboration between the
 school and district crisis response teams, community, and state organizations is critical to
 responding to the many needs of children and families.
- Immediately following a natural disaster schools should identify children who are highrisk and plan interventions that may include discussions, counseling or family therapy.
 Schools should also provide time for students and staff to discuss the disaster regarding
 feelings and experiences, and securing additional mental health support is critical for
 coordinating services in the aftermath of a disaster.
