The Transfer Process is one of the first tasks to be completed at the beginning of the school year for students eligible for special services enrolling in your district. The transfer process is outlined in the Standards and Indicators Manual under the 500 section (In-State) & 550 section (Out-of-State). Key Points:

- Be sure your building level staff are trained to review incoming paperwork and to listen for key phrases or comments related to suspecting whether a newly enrolled student is a student with a disability.
- There are NO interim IEPs.
- There are NO amendments to IEPs received at transfer

#### **Transfer Student Compliance Reminders**

**MYTH:** An amendment can be made to a transfer IEP if it cannot be implemented as written.

**FACT:** The IDEA does not provide a process to allow for transfer IEPs to be amended. Instead, the LEA must review the transfer IEP and make a determination of whether to accept or reject the transfer IEP. If accepted, the transfer IEP becomes the LEA's IEP and must be implemented as written with the LEA assuming all responsibility for any child complaint or due process allegations related to that IEP. If the IEP is rejected, then the LEA must provide comparable services until such time a new IEP is developed for the student.

**MYTH**: Comparable services are decided solely by the LEA and can be different from what was required by the transfer IEP.

**FACT:** The LEA in consultation with the parents of the transfer student must determine what special education services are comparable to those described in the transfer IEP. Note that the term "comparable" is defined as "similar" which indicates the services do not have to be exactly same as those on the transfer IEP. The model Transfer Documentation forms for both in-state and out-of-state transfers was updated in July 2015 to include a place to document the consultation with parents and the decisions regarding comparable services being offered by the LEA. These model forms also provide step-by-step guidance for to assist LEAs with compliance in the transfer process
