The Transfer Process is one of the first tasks to be completed at the beginning of the school year for students eligible for special services enrolling in your district. The transfer process is outlined in the Standards and Indicators Manual under the 500 section (In-State) & 550 section (Out-of-State).

Key Points:

- Be sure your building level staff are trained to review incoming paperwork and to listen for key phrases or comments related to suspecting whether a newly enrolled student is a student with a disability.
- There are NO interim IEPs.
- There are NO amendments to IEPs received at transfer

## COMPLIANCE REMINDERS

Routine Checking of Hearing Aids and External Components of Surgically Implanted Medical Devices (34 CFR 300.113)

- This agency must ensure that hearing aids worn in school by students with hearing impairments, including deafness, and the external components of surgically implanted medical devices are functioning properly.
- For a student with a surgically implanted medical device who is receiving special education and related services, this agency is not responsible for the post-surgical maintenance, programming, or replacement of the medical device that has been surgically implanted (or of an external component of the surgically implanted medical device).

A copy of the state approved procedural safeguards available to the parents of a student with a disability shall be given to parents only one (1) time a school year, except that a copy also shall be given to the parents:

- Within five (5) school days of initial referral or parental request for evaluation;
- upon receipt of the first due process complaint and upon receipt of the first child complaint in the school year;
- upon a disciplinary change of placement; and
- upon request by the parent.
